# WORLD WINGS INTERNATIONAL, INC. DATA COLLECTION AND PROCESSING AGREEMENT

## 1. Collection, Processing, and Use of Personal Information at World Wings International, Inc.

- We collect information from our members because it is necessary for World Wings International, Inc. to use that information in the course of business.
- We review the information you provide about your employment with Pan Am (when and where you were based) to ensure you are eligible for membership, and occasionally to find members meeting certain criteria.
- We collect your maiden name because we might not recognize your married name, and we collect your spouse/partner name so that we can personalize our interactions.
- We collect your contact information (address, email, phone) so that we can send you Jet Wings, send chapter newsletters, inform you about events, and communicate other items of importance or interest.
- We publish a member directory so that members can find one another and communicate.
- We allow you to update your own information online, or we update information for you as needed after communication between the chapters and the international board.
- We hold credit card information (paper only, no online storage) for member-requested automatic renewals.
- We provide a means of registering for our annual convention and provide a list of those attending so you can see if your friends are going.
- We store this information on a central server and on the computers of international and chapter officers. The server, and some computers, are backed up on line or to storage media in case of a failure.
- We supply a file of contact information to our printer for Jet Wings mailings. We also maintain names and emails at ConstantContact.com, which enables us to send out our mass emailings (we cannot perform mass mailings from our personal emails).
- When people visit our site, we use analysis tools from Google to collect info about the type of device being used, browser used, country of origin, and which pages are visited. This info helps us display pages correctly (smartphone vs computer, etc., and Google vs Safari, etc.) and helps us plan site enhancements.

All of these things, whether done electronically or by pen on paper, fall under the umbrella of data collection and processing and, as a result, fall under the new law. As an organization, we cannot function without this information.

## 2. Sale and/or Sharing of Data with Outside Entities/Persons

- We DO NOT sell our data to anyone.
- We DO NOT give our data to outside persons or entities, except as explained above.
- Except as explained above, we DO NOT allow our members to sell or give our data to outside persons or entities.

## 3. What This Means to You:

- **You must read and sign this document and select “Opt In” to continue your membership. If you select “Opt Out,” your membership will be cancelled and your information will be deleted from our system within 60 days.**
- You may notify us at any time, in writing, that you wish to be removed. We will remove you within 60 days.
- If you do not renew, your information will be retained for no more than 5 (five) years, after which it will be removed. You may also notify us, in writing, that you wish to be removed sooner. We will remove you within 60 days.
- Per the bylaws of World Wings International, dues are not prorated and are not refundable.
